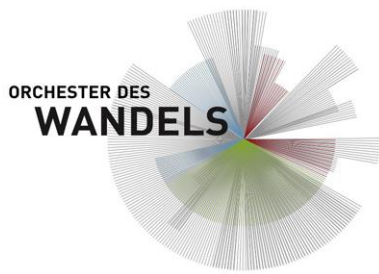

Privacy Policy

1. Data Storage, Authorized access

By joining Orchester des Wandels Deutschland association, the member provides his address, email address, telephone number and bank details. This information is stored in the EDP systems of the secretary and treasurer as well as in the association's own internet-based EDP system. The personal data is protected by appropriate technical and organizational measures against the knowledge of third parties. Other information about members and information about non-members will only be processed or used by the association if it is useful for promoting the purpose of the association (e.g. storage of telephone and fax numbers of individual members) and there is no indication that the data subject has an interest worthy of protection which conflicts with the processing or use.

2. Membership roster

In addition to the board members, only those members of the association whose function requires knowledge of certain member data shall receive a member roster. In order to exercise the statutory rights, the board of directors issues a list of members with names and addresses of the members to those requesting only with a written assurance that the addresses will not be used for other purposes.

3. Datenaufbewahrung

Upon resignation, the member's stored data will be deleted from the member directory. Personal data of the resigning member which concern the cash management will be kept in accordance with the tax law provisions for up to ten years from the written confirmation of the resignation by the board.
